Tribal nations are on the frontlines of climate change. SCEP is committed to expediting processing of funding awards to Indian tribes, enabling them to develop and implement rebate programs for high-efficiency electric homes.





Home Electrification and Appliance Rebates Program for Indian Tribes

Program Benefits

The Home Energy Rebates will help households...

- > Save money on energy bills
- > Upgrade to clean energy equipment
- > Improve energy efficiency
- > Improve their comfort
- > Support a stable power grid
- > Reduce indoor and outdoor air pollution

Additionally, these rebates provide specific opportunities to increase the install base of efficient, clean energy equipment in homes in underserved and underrepresented communities.

Overview of the Tribal Home Electrification and Appliance Rebates Program

Tribal Home
Energy Rebates
Section 50122 of the

Inflation Reduction Act

Amount: \$225M for Indian Tribes (by formula)

Apply Through: May 31, 2025

Recipients: Indian Tribes and Alaska Native Corporations

Goal: Develop, implement, and subsidize residential electrification and appliance upgrade projects for Tribal and Alaskan Native households.

Indian Tribes and Alaska Native Corporations may use funds to:

- ✓ Provide rebates to households, building owners, and contractors
- ✓ Work with trusted contractors & retailers to streamline rebate processing.
- ✓ Verify quality installation and document home upgrades
- ✓ Help households bundle funds & financing to further reduce upfront costs



Eligible Upgrades Covered by Tribal Rebates Program Funding

Maximum Rebate Per Improvement		
Electric heat pump HVAC system*	up to \$8,000	
Electric heat pump water heater*	up to \$1,750	
Electric stove, cooktop, range, or oven*	up to \$840	
Electric heat pump clothes dryer*	up to \$840	
Electric circuit panel upgrade	up to \$4,000	
Insulation, air sealing, and ventilation	up to \$1,600	
Electric wiring upgrades	up to \$2,500	
Electric circuit panel upgrade Insulation, air sealing, and ventilation	up to \$4,000 up to \$1,600	

Total electrification rebates cannot exceed \$14,000 per household


While subject to the caps noted in the chart, rebates can cover:

- > Up to full costs for low-income households (less than 80% Area Median Income)
- > Up to half of project costs for moderate-income households (80 -150% Area Median Income)

Tribes can choose to restrict rebates to certain technologies for local needs, such as only using rebates for wiring of non-electrified tribal households.

^{*}Tribal home energy upgrade projects must also use equipment that is Energy Star certified.

Funding Overview



The law authorizes up to 3% of total funds for DOE program administration & technical assistance as well as up to 20% of State & Indian Tribe funds for program administration.

Simplified requirements for Tribal Rebates designed to help Tribes more easily apply, follow EO 14112 goals of making federal programs more accessible, flexible, and equitable for Tribes.

Key Program Provisions: Eligibility

Eligibility for the Tribal Home Electrification and Appliance Rebates Program are limited by Income and Technology, and the Tribes have discretion to further restrict eligibility.

Eligible Income Limits

Rebate recipients must be lowor moderate-income residents

- "Low-income": 80% AMI
- "Moderate-income": 150% AMI
- "AMI": Area Median Income, as determined by HUD

Tribal Discretion

Tribes can further restrict eligibility, for both income and technology.

Eligible Technology

Rebates are available only for certain technologies, such as:

- electric heat pump for space conditioning,
- electric heat pump water heaters,
- electric heat pump clothes dryer,
- stove (or cooktop or oven),
- insulation products,
- · electrical wiring,
- · electrical panel.

Appliances must be EnergyStar-certified.

Key Program Provisions: Program Design

Program Design should consider these four priorities for the Tribal Home Electrification and Appliance Rebates Program:

Point-of-sale or Point-of-Installation

Rebates are designed for point-of-sale (at retailer or distributor) or point-of-installation (at the dwelling unit/job site in the form of a discounted invoice or coupon redemption).

Qualified Contractors

Qualified contractors must perform the work to ensure good consumer experience.

Document Retention

Program administrator must collect and retain project-level documents (invoice, receipt, etc.) and must report project and program data to DOE per grant document for tracking.

Tribal Housing Entities

Tribal housing entities could play a key role as contractors & ease administrative burden






Where Can I Find Application Requirements?

How Do I Ask Questions?

All questions must be submitted either to:

- 1. the IRA Home Rebates Programs website, or
- 2. the Home Rebates email irahomerebates@hq.doe.gov.

Submitting questions through the Home Rebates website is preferred.

All questions will be responded to in a timely manner and will be **publicly posted** on the IRA Home Rebates website.

Any responses received from sources other than what is publicly posted by DOE are not binding.

Application and Program Implementation Support

Tribal Consortium and Designated Third-Party Implementers:

- Multiple Tribes may submit a single application to run a joint program as a Tribal Consortium
 - Tribes in a consortium can pool the 20% of their awards set aside for administration.
- Tribes may also designate a 3rd party agent to apply on their behalf
- 3rd party program implementers may administer a program for a Tribe or a Consortium

Technical Assistance to be provided by DOE:

- HER Team will provide ongoing TA to tribal applicants, including assistance with completing various application forms and documents
- HER Team will provide a sample application and a sample QA plan that applicants can use as a guide (with different versions for small rural tribes, larger awards, etc.)



Application Deadline Full application must be submitted via the PAGE online system at https://www.page.energy.gov/default.aspx	May 31, 2025



Pre-Application Requirements

Important! Allow at least 21 days to complete registrations.

Pre-Application Step	Notes
Obtain a Unique Entity Identifier (UEI)	Obtain a UEI number from the <u>System for Award Management (SAM.gov)</u> website. Subawardees at all tiers must obtain UEI numbers and provide the UEI to the prime awardee before the subaward can be issued.
Register in the System for Award Management (SAM)	Register at https://sam.gov. It is suggested that the process be started as soon as possible. Prime awardees must update their SAM registration annually.
Register in FedConnect	Register to receive and acknowledge your award at https://www.fedconnect.net/ .
Establish a Performance and Accountability for Grants in Energy (PAGE) Login	Register for a PAGE account to receive your PAGE login information. Tribe Energy Office designated points of contact will receive their PAGE login information via email from Page-Notification@hq.doe.gov.

Pre-Application Recommended Step

Recommended timeline to submit a letter of intent to apply: May 15, 2024

If interested in applying for these funds, Indian Tribes are asked to submit a Letter of Intent to Apply.

Example provided in Appendix C of the Program Requirements and Application Guidelines document

The letter should express the applicants' intent to apply for these funds and whether they intend to apply individually or as a Tribal Consortium. The letter should identify the lead and member Tribes. Home Electrification and Appliance Rebates Program for Indian Tribes

Instructions for a "Head of Government Letter", "Tribal Council Resolution", or other similar instrument:

A "Head of Government Letter", "Tribal Council Resolution," or other similar instrument must be signed by a person or entity appointed by the Indian Tribe's legally authorized entity and consistent with the Indian Tribe's customs, documenting their appointment as the sole entity within the Indian Tribe to apply for, receive, and administer the award as authorized by Section 50122 of the Inflation Reduction Act of 2022 and as described in the Administrative and Legal Requirements Document.

If applying as a Tribal Consortium, the document must identify the Indian Tribe to act on its behalf as lead Indian Tribe of the Tribal Consortium and receive their allocations. The document should state that the lead Indian Tribe will apply for grant funding and administer the grant on behalf of all participating consortium Indian Tribes. Please note that only the eligible Indian Tribe or the lead Indian Tribe of the Tribal Consortium may be the awardee. The eligible Indian Tribe and/or the lead Indian Tribe of the Tribal Consortium, as applicable, will ultimately be responsible for satisfying all grant requirements

Full Application Requirements

Tribes must address the application requirements specified. All requirements must be addressed to receive Federal funding and to launch Tribe programs.

However, DOE recognizes that the Tribe may not be equipped to adequately respond to all requirements and plans without program support from program implementers and experts.

Tribes are required to submit their responses to DOE through two documents:

- 1. **Tribe Application.** Tribes may submit a single package of responses for all application requirements.
- **2. Tribe Implementation Blueprint**. For specific requirements identified by DOE, Tribes may elect to defer submission of those responses to their Tribe Implementation Blueprint.

Overview of Application Package Components

- 1. Completed SF424
- 2. Completed SF424A
- 3. Completed Budget Justification Workbook
- 4. Completed Planned Activities
- 5. Consumer Protection Plan
- 6. Completed Narrative Document
- 7. Pre-Award Information Sheet
- 8. Tribal Council Resolution, or other similar instrument
- 9. Any additional required documents as stated in ALRD or Program Requirements

Implementation Blueprint

An Implementation Blueprint must be submitted after receipt of the award and a minimum of **90 days** prior to planned program launch.

DOE will provide feedback and approval to proceed.

- Tribes must receive DOE approval on the Implementation Blueprint before launching their program.
- In addition to specified requirements, an Implementation Blueprint must include:
 - a) Consumer Protection Plan

Requirements that can be deferred in the Implementation Blueprint are marked with an "X" within the application requirements tables.

Application Submission

- The application must be submitted via the PAGE online system at https://www.page.energy.gov/default.aspx
- Grantee must check for successful transmission.
- DOE reserves the right to request additional or clarifying information for any reason deemed necessary. Applications will be reviewed for consistency with the program objectives.
- Application package requirements outside of PAGE shall be submitted as attachments to the SF-424 Application.


