Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to administer Congressionally Directed Spending to South Coast Air Quality Management District to design and mockup a hydrogen fuel cell battery electric locomotive to accomplish the requirements of a rail switching application.

Award activities will take place at Wabtec Corporation in Erie, PA.

The award includes one budget period (BP) and one task, including multiple action items. The proposed project consists of laying out a fuel cell battery locomotive design to accomplish the needs of a rail-switching application. The layout will show the following key subsystems: fuel cells, fuel cell cooling, batteries, battery thermal management, liquid hydrogen storage, power conversion cab, operator cab, truck motors, platform, and DC converters.

Proposed activities would be limited to design work and would occur entirely within existing research and development facilities that are purpose-built for the type and scale of activities being proposed. No change in the use, mission, or operation of existing facilities would arise out of this effort.

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on sensitive resources, including those of an ecological, historical, cultural, and socioeconomic nature, and found no effects that would be expected to result from the proposed project activities.
