Project Title: Install Carports and Electric Vehicle Charging Station at the Legacy Management Field Support Center at Grand Junction, Colorado

Location: Legacy Management Field Support Center at Grand Junction, Colorado

Proposed Action or Project Description:

The DOE-LM is proposing to install carports and a patented Beam EV ARC solar-powered level 2 dual-port electric vehicle charging station (EVCS) in the U.S. General Services Administration (GSA) lot at the Legacy Management Field Support Center (LMFSC) at Grand Junction, Colorado, in Mesa County, just outside of Grand Junction city limits. As part of environmental stewardship, LM must acquire zero-emission electric vehicles as vehicles are replaced in the LM fleet to meet the requirements in Executive Order 14057 Section 102(a)(ii), "100 Percent Zero-Emission Vehicle Acquisitions by 2035, Including 100 Percent Zero-Emission Light-Duty Vehicle Acquisitions by 2027." In support of this goal, one EVCS would be installed within the LMFSC GSA lot at the southwest exterior corner of Building 7. The need for the EVCS would provide a charging station for electric vehicles and the carports would provide shelter for all-terrain vehicles and other LM property and assets.
