On April 22, 2024, Venture Global Plaquemines LNG, LLC (Plaquemines LNG) filed an application in Docket No. 24-33-LNG requesting blanket authorization to export liquefied natural gas (LNG) that has been previously imported into the United States from foreign sources in an amount up to the equivalent of 6 billion cubic feet (Bcf) of natural gas for a period of two years beginning July 22, 2024. While the requested quantity of 6 Bcf was included in the application, an alternative measure of 600 million cubic feet (MMcf) was specified at pages 1, 7, 9, 12, and 16. This reference was in error and should instead have specified 6,000 MMcf, as equivalent to the requested 6 Bcf. Accordingly, Plaquemines LNG hereby corrects the manifest errors in its application by replacing all references in it to 600 MMcf with 6,000 MMcf.
