**Supervisor Determination:**

As required by 5 C.F.R. § 2635.204(g)(4), based on my review of the information provided regarding this event, as the agency designee I hereby determine that the employee's attendance at this event is in the agency's interest and that the agency's interest outweighs the concern that the employee may be, or may appear to be, improperly influenced in the performance of the employee's official duties. In making this determination, I have considered (i) the importance of the event to the agency; (ii) the nature and sensitivity of any pending matter affecting the interests of the person who extended the invitation and the significance of the employee's role in the matter; (iii) the purpose of the event; (iv) the identity of the expected participants; (v) whether acceptance would reasonably create the appearance that the donor is receiving preferential treatment; (vi) whether the government is also providing persons with views or interests that differ from those of the donor with access to the government; and (vii) the market value of the gift of free attendance. This determination is contingent upon ethics counsel review of this event.
