ORDER GRANTING REQUEST TO AMEND AUTHORIZATION TO IMPORT AND EXPORT NATURAL GAS FROM AND TO CANADA

DOE/FECM ORDER NO. 5088-A

On January 11, 2024, the Office of Fossil Energy and Carbon Management (FECM) of the Department of Energy (DOE) issued DOE/FECM Order No. 5088 (Docket No. 23-136-NG), under section 3 of the Natural Gas Act (NGA).<sup>1</sup> That order granted Puget Sound Energy, Inc. (Puget Sound Energy) authorization to import and export up to a combined total volume equivalent to 300 billion cubic feet (Bcf) of natural gas from and to Canada by pipeline, for a two-year term that began on March 1, 2024, and extends through February 28, 2026.

On February 20, 2024, DOE was notified that Puget Sound Energy requested to increase the authorized volume amount from 300 Bcf to 400 Bcf effective March 1, 2024.<sup>2</sup>

DOE finds that Puget Sound Energy's request to amend the specified authorization to increase the currently authorized volume for the import and export of natural gas from 300 Bcf to 400 Bcf for a term not exceeding two years is consistent with the public interest, pursuant to NGA section 3.

## **ORDER**

Pursuant to section 3 of the Natural Gas Act, it is ordered that:

A. In DOE/FECM Order No. 5088, the volume amount is amended from 300 Bcf to 400 Bcf for a term not to exceed two years.
