Proposed Action Title: M-TMOD-Z-00007 - Saltstone Hopper Overflow Container Modification

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The proposed activity (PA) is the design, review, and implementation of Temporary Modification (TMOD) M-TMOD-Z-00007. The process vessel ventilation (PVV) line for the Saltstone Hopper Overflow Container (SHOC) is not venting properly due to an obstruction. The PA removes the welded cap above valve Z-210000-Z-V-9004 and adds a vent duct that runs to a portable fan and High Efficiency Particulate Air (HEPA) filtration unit (e.g., a MAC) providing ventilation for the SHOC into the process room until the obstruction is removed and the normal PVV line can be used for ventilation.
