Proposed Action Title: Replacement of Scanning Electron Microscope (SEM) in Inert Metallography Laboratory (IML)

Program or Field Office: Savannah River Site

Proposed Action Description:

The JEOL JSM-6460LV Scanning Electron Microscope (SEM), along with all peripheral attachments, are to be removed and replaced with a new SEM. The new SEM, with needed attachments and accessories, will fit into the existing laboratory floor space in the Inert Metallurgical Laboratory (IML) in Building 234-H and will be placed in proximity to the current SEM's location.

Revision 0 of this EEC currently addresses the design and procurement portions of this modification. This EEC will be revised to include the facility modification portion of the work prior to construction and installation.

Revision 1: Replacement transformer won't be needed for the new equipment. Also extended activity date

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
