Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B5.16 Solar photovoltaic systems

The installation, modification, operation, and removal of commercially available solar photovoltaic systems located on a building or other structure (such as rooftop, parking lot or facility, and mounted to signage, lighting, gates, or fences), or if located on land, generally comprising less than 10 acres within a previously disturbed or developed area. Covered actions would be in accordance with applicable requirements (such as local land use and zoning requirements) in the proposed project area and would incorporate appropriate control technologies and best management practices.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to administer Congressionally Directed Spending to the City of Largo for the design and installation of a 150-kilowatt roof-mounted solar photovoltaic (PV) system and associated components at the Largo Public Library. These activities would aim to reduce grid-purchased energy by at least 12% and would assist the City of Largo in meeting its "Ready for 100" commitment to power 50% of all municipal operations with zero-emission, renewable energy by 2030. System design and installation would be carried out by a qualified Energy Service Company. Energy audits would be carried out by the City of Largo's Public Works Sustainability Team. PV installation, data collection, and monitoring would occur at the Largo Public Library in Largo, Florida.

All project activities would be completed in existing, purpose-built facilities. No facility modifications would be needed to perform project activities. Potential hazards include safety risks related to construction activities. All necessary permits would be obtained, and existing city health, safety, and environmental policies and procedures would be followed, including personnel training, proper personal protective equipment, engineering controls, monitoring, and internal assessments.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.
