

Proposed Action Title: Steel Creek/PAR Pond Piezometer Redevelopment, Abandonment & Reinstallation.

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Re-develop 22 piezometers and 2 inclinometers in the vicinity of the Steel Creek Dam, and 48 piezometers in the vicinity of PAR Pond Dam. Eleven (11) piezometers will be abandoned in place, and nine (9) piezometers will be reinstalled to monitor water levels within the Steel Creek Dam.

Rev. 2: Additionally, two piezometers will be abandoned due to broken or plugged risers/screens that could not be cleared and five piezometers (P-1BR, P-5R, P10.9R, P-11.2R, P-11R) will be installed to monitor water levels withing the PAR Pond Dam.
