Project Title: Extraction Well Repair at the Shiprock, New Mexico, Disposal Site

Location: Shiprock, New Mexico, Disposal Site

Proposed Action or Project Description:

LM is proposing to perform repairs on extraction wells 1089 and 1109 at the Shiprock, New Mexico, Disposal Site. Repair activities would include replacement of the pitless adapters on each well. The proposed repairs are necessary to continue extracting groundwater to reduce the spatial extent and concentrations of the contaminant plume, supporting LM's goal of protecting human health and the environment.

Categorical Exclusion(s) Applied:

B1.3 Routine Maintenance B5.12 Workover of Existing Wells

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1501.9(e)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.1(g)(3)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized by the LM Director per DOE Policy 451.1), I have determined that the proposed action fits within the specified classes of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
