Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B1.31 Installation or relocation of machinery and equipment	Installation or relocation and operation of machinery and equipment (including, but not limited to, laboratory equipment, electronic hardware, manufacturing machinery, maintenance equipment, and health and safety equipment), provided that uses of the installed or relocated items are consistent with the general missions of the receiving structure. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Ballard US iInc. (Ballard) to install a bipolar plate (BPP) manufacturing line within their Rockwall Gigafactory facility in Rockwall, Texas, which is in the early stages of construction. Construction of the Rockwall Gigafactory is not being funded by DOE and is not considered a connected action.

Separately from this award (DE-EE0011346), additional DOE funds (DE-EE0011342) have been awarded to Ballard to install a membrane electrode assembly (MEA) manufacturing line within their new facility. The MEA manufacturing line is considered a connected action because it is federally funded and would be installed concurrently with the manufacturing lines installed under this award. Potential impacts of the MEA manufacturing line installation are considered in this NEPA Determination.

Award activities would be executed over three budget periods (BP). Project tasks repeat in all three BPs, and would include proof of principle trials, project administration, plate forming, impregnation and wash, curing, laser cutting, plate assembly, end of line quality control, BPP manufacturing testing, and creating a community benefits plan.

Award activities would occur entirely within existing purpose-built manufacturing facilities. The new facility has been designed to house the manufacturing lines and award activities. No new modifications to the facility would be required. No change in the use, mission, or operation of existing facilities would arise out of this effort.

Award activities would involve handling and use of various hazardous materials including volatile organic compounds. Project activities involving hazardous materials pose no risk to the public. Hazardous materials would be utilized, managed, stored, and disposed of in accordance with applicable federal, state, and local environmental regulation.

Existing laboratory and governmental health and safety policies and procedures would be followed, including employee training, proper protective equipment, engineering controls, monitoring, and internal assessments.

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on sensitive resources, including those of an ecological, historical, cultural, and socioeconomic nature, and found no effects that would be expected to result from the proposed project activities.

# FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
