Proposed Action Title: Hanford Oxidation of Organics for Sample-and-Send

Proposed Action Description:

Non-radioactive laboratory testing using simulants to study solution oxidation of trace regulated organic chemicals using a 4 to 8 molar sodium alkaline simulant. The trace chemical spikes are from some of the organic chemicals shown in 40 CFR 268.48.
