Proposed Action Title: Install New Valve Upstream of V-019 at 681-3G

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Install new valve upstream of V-019 at 681-3G.

A new gate valve will be mounted downstream of the existing V-019 valve. The new valve will have supports mounted under it to reduce the cantilever load on the old valve. New stem guides and floor box will be required to shift the existing valve extension approximately 11 inches to the new valve stem. The out of service valve is to be left in the "open" position after installation of the new valve.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
