

Proposed Action Title: 221-H Canyon NWC 900MHZ Installation

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The general services H-Canyon New Warm Crane (NWC) Radio Frequency system and equipment have become problematic and obsolete. While operating the NWC, Crane Operators are experiencing loss of motive power and camera/video functionalities. The NWC control functions and video data system are currently transmitted through the same Catel Radio Frequency system and components. We currently have no spare components and they are obselete. Current and forecast site missions require reliable crane operation with commercially supported components including the controls.
