Proposed Action Title: Surplus Plutonium Disposition (SPD) Project N-Area Support Buildings

## Proposed Action Description:

Revision 0: With the evolving construction of the Surplus Plutonium Disposition (SPD) Project an existing Quonset hut (763-111N) will be removed, and a new fabric tension structure (Quonset hut) will be installed in N Area. The enlarged Quonset hut is needed to meet the warehouse and inventory demands. A mobile office structure and two new materials storage shelters to the west of existing Building 714-7N. This project will take place in phases.

Revision 1: Scope update. SPD-owned Quonset hut (763-11N) will no longer be removed.

Revision 2: Updated proposed activities to reflect current planned activities.

To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
