

Proposed Action Title: Upgrade and Install DWPF 291-S Zone 1 Stack CAM (MT-WD-2022-00020)

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Replace 291-S Zone 1 Exhaust Stack continuous air monitoring systems by:

1. Replace hotwire anemometer sensors with a pitot tube array;

2. Replace the VALTEC MOD V radiation monitor with an ICAM system; and

3. Replace the isokinetic sampler with a shrouded probe
