

Proposed Action Title: Hot Air Decontamination Relocation to 233-H per P-DCP-H-18001

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This EEC covers the implementation via P-DCP-H-18001 for the relocation of part of the 234-H Finishing Line process to 233-H. Functions and capabilities of the Finishing process in 234-H that are to be relocated to 233-H include: trimming and gauging, hot air decontamination, and final decontamination. These processes will be relocated into Finishing Line 1.

This EEC (Rev 1) is being revised to cover the implementation of Hot Air Decontamination (HAD) by DCP # P-DCP-H-18001.

Rev 2. was created to extend the activity end date.
