Proposed Action Title: Construction Temporary Power for Building 233-H

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

It is anticipated that additional electrical capacity will be required by Construction during the CY 25 outage within Building 233-H to provide power for welding machines and miscellaneous hand power tools. This MT will permanently install cable within conduit that will connect to Motor Control Centers (MCC) T160-600-4 and T160-600-5, located in Building 233-H. The cable will be connected to portable power boards or temporary power stations within Building 233-H. They will be located as needed by Construction during performance of work on CY 25 Projects Y839 through Y844.

Refer to MT-TRI-2023-00008 Revision 1 and the file labeled "Performance and Design Criteria for MT-TRI-2023-00008 Revision 1", for the design input. Drafts of the documents are available in SPF.

Contrary to Revision 0 of the MT, a temporary portable generator is no longer required, which is why Revision 1 of the MT is being issued. Also, penetrations through the 233-H Building hatch to enable installation of power conductors from the generator to the temporary power stations inside the building will not be installed. Lastly, manual transfer switches will not be installed. Alternate power for construction will only be supplied by the MCCs inside the building.

Revision 1 of this EEC currently addresses the design and procurement portions of this modification. This EEC will be revised to include the facility modification portion of the work prior to construction and installation.
