Proposed Action Title: Install 233-H Rm 16 Isolation Valves

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Current 233-H CHW piping configuration requires isolating CHW to Central Control Room (CCR) for any work on CHW lines in Rm 16. CHW isolation valves need to be added in Rm 16 prior to FY25 outage that will allow isolation of CHW in Rm 16 without impacting the 233-H CCR CHW.
