Proposed Action Title: Complex Metal Hydrides

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This project develops new complex metal hydride materials for hydrogen storage. The alkali-metal hydrides, alanates, borohydrides, hydrocarbon solvents, metallorganic complexes, nanomaterials, metals and their salts will be acquired, stored and processed in an Argon filled glove box due to their sensitive nature to air and moisture. The processes include but are not limited to hydride dissolution in organic solvents, impurities filtration, hydrides recrystallization, and hydrides blending with additives (metallorganic complexes, metals and salts), melt processing, and absorption/desorption for material property testing.

Rev. 1 Changes include: a new project contact, editorial changes, and an extended end date.

Rev. 2 The Parr reactor will also be used to convert alkali metals into alkali metal chlorides using chlorine gas.

Rev.3 Addition of electrochemical measurements on inorganic oxides and porphyrins.

Rev. 4 Synthesis, modification, and characterization of MXenes will be performed.
