Revision 2: Revise the summary, detailed description and activity end date of this EEC based on Revision 1 of MT-TRI-2020-0014. Also, add two reference drawings. The waste characterization of the modification has not changed.

In October 2018, Simplex, the manufacturer of the existing 234-H FACP (Fire Alarm Control Panel), provided notification of "End of Service Life" for the Simplex model 4100 FACP currently installed in Building 234-H. The "End of Service Life" notification means that Simplex will no longer provide technical support nor provide necessary Original Equipment Manufacturer (OEM) replacement parts and components for servicing and maintaining operation of the existing Building 234-H Simplex model 4100 FACP.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
