ORDER

For the U.S. Department of Energy ("DOE"):

- 1. On July 19, 2023, under the above-listed case number, DOE issued a Notice of Proposed Civil Penalty to Changsha Tianbi Trading Company ("Respondent") to pursue a civil penalty for knowingly distributing in commerce showerhead basic models without submitting to DOE a certification report certifying that those basic models comply with the applicable energy conservation standards.
- 2. Showerheads are covered products. 10 C.F.R. § 430.2.
- 3. Pursuant to 10 C.F.R. § 429.12, each manufacturer must submit to DOE a report certifying that each basic model of a covered product meets the applicable energy conservation standard, before distributing each basic model in commerce and annually thereafter.
- 4. Failure to submit a certification report for a covered product in accordance with 10 C.F.R. § 429.12 is a prohibited act pursuant to 10 C.F.R. § 429.102(a)(1) and subject to civil penalties as described in 10 C.F.R. § 429.120.
- 5. Pursuant to 10 C.F.R. § 429.120, each day that a manufacturer fails to submit a certification report for a basic model is a separate violation.
- 6. Respondent admitted the following:
 - a. Respondent has manufactured¹ showerheads, including the basic models that contain the following individual models: 21651, 72020, and "High Pressure Shower Head Filter, FEELSO 2-IN-1 15 Stages High Output Hard Water Softener

¹ "Manufacture" means to manufacture, produce, assemble, or import. 42 U.S.C. § 6291(10).

Showerhead with Filter Cartridge for Hard Water Remove Chlorine and Harmful Substances" ("the basic models").

- b. For at least 365 days, Respondent has distributed in commerce² the basic models.
- c. Respondent knowingly failed to submit a certification report for the basic models, in violation of 10 C.F.R. § 429.12.
- 7. Based on the information above, I find that Respondent knowingly committed Prohibited Acts by manufacturing and distributing in commerce a basic model of a covered product without submitting to DOE a report certifying that the basic model complies with the applicable energy conservation standards. *See* 42 U.S.C. § 6302; 10 C.F.R. § 429.102(a)(1).
- 8. Accordingly, pursuant to 10 C.F.R. § 429.120 and 42 U.S.C. §§ 6303 and 6316, I **HEREBY ASSESS** a civil penalty of \$25,000, **ORDER** Respondent to pay the assessed civil penalty in full within 30 calendar days, **AND ORDER** that the Settlement Agreement attached to this Order is adopted.
