# THIRD NOTICE OF NONCOMPLIANCE DETERMINATION

General service lamps are covered products subject to federal energy conservation standards. *See* 42 U.S.C. § 6295(a)(1), 6295(i)(6), 10 C.F.R. § 430.32(dd). Effective July 25, 2022, the sale in the United States of any general service lamp that does not meet a minimum efficacy standard of 45 lumens per watt ("lm/W") is prohibited. 10 C.F.R. § 430.32(dd).

#### **FINDINGS**

On November 30, 2023, the U.S. Department of Energy ("DOE") issued a Notice of Noncompliance Determination ("First NND") to X-S Merchandise Inc. ("X-S"), in which DOE notified X-S that various general service lamp models sold in the United States by X-S do not meet the minimum efficacy standard. On April 22, 2024, X-S notified DOE that general service lamp models 64594, 46160, and 94401 are equivalent to models identified in the First NND, and that units of those models remained under X-S's control and provided quantities. Accordingly, on April 26, 2024, DOE issued to X-S a Second NND finding that those models do not meet the minimum efficacy standard. In July and September 2024, X-S informed DOE that it had sold in the United States additional general service lamp models that do not meet the minimum efficacy standard and provided quantities. Accordingly, DOE has determined that the basic models containing the following individual models sold by X-S in the United States do not meet the applicable federal energy conservation standard of at least 45 lm/W:

#### NOTICE

Sale in the United States of a general service lamp that does not meet the applicable energy conservation standard is a violation subject to civil penalty, regardless of the issuance of this Notice. X-S informed DOE it has ceased selling in the United States or otherwise distributing in commerce all units of these basic models and any other basic models that do not comply with the minimum efficacy standard.

### CONSEQUENCES FOR CONTINUING TO DISTRIBUTE THE BASIC MODELS

If X-S continues distributing any units of the above-listed basic models or any other basic models that do not comply with the applicable energy conservation standard, DOE may seek a judicial order to restrain further sale and may assess a higher civil penalty for units sold after the date of this Notice.

The sale in the United States of any units of a noncompliant basic model may result in DOE seeking all appropriate legal remedies available under federal law, including injunctive relief at civil penalties with respect to each unit of the basic model sold in violation of federal law.
