Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

### Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the Office of Personnel Management (OPM) as part of the Assisting Federal Facilities with Energy Conservation Technologies (AFFECT) grant program. The funding provided would assist in energy efficiency and resiliency improvements at OPM Headquarters, The Theodore Roosevelt Building, in Washington, DC.

AFFECT funding for this award would total \$500,000 and would be applied to the modernization of energy systems within the building. This National Environmental Policy Act (NEPA) determination applies to the distribution of funds only. Because OPM is a federal agency, it is required to comply with NEPA for this project. This would include completing an environmental review for the project, including any necessary consultations and geotechnical or other surveys prior to a decision whether to proceed. If OPM proceeds with the proposed project after their NEPA review, they would be required to obtain all necessary permits and follow appropriate environmental, health, and safety measures. OPM must provide its final NEPA determination(s) to their DOE Federal Energy Management Program (FEMP) Technical Project Officer (TPO) or point of contact.

#### NEPA PROVISION

DOE has made a final NEPA determination.
