Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A1 Routine DOE business Routine actions necessary to support the normal conduct of DOE business limited to administrative, financial, and personnel actions.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the National Aeronautics and Space Administration (NASA) as part of the Assisting Federal Facilities with Energy Conservation Technologies (AFFECT) grant program. The funding provided would assist in the development of a dynamic Battery Energy Storage System at the White Sands Test Facility in Las Cruces, New Mexico.

AFFECT funding for this award would total \$700,000 and would be applied to the design, instillation, and testing of dynamic output energy control system connected to a photovoltaic array. This National Environmental Policy Act (NEPA) determination applies to the distribution of funds only. Because NASA is a federal agency, it is required to comply with NEPA for this project. This would include completing an environmental review for the project, including any necessary consultations and geotechnical or other surveys prior to a decision whether to proceed. If NASA proceeds with the proposed project after their NEPA review, they would be required to obtain all necessary permits and follow appropriate environmental, health, and safety measures. NASA must provide its final NEPA determination(s) to their DOE Federal Energy Management Program (FEMP) Technical Project Officer (TPO) or point of contact.
