**A9 Information** and dissemination

## Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to authorize the administration of the American-Made Tribal Colleges and Universities (TCU) Energy and Food Sovereignty Nexus Prize to support the design and development of student-led demonstration projects that increase their knowledge on clean energy and food sovereignty on TCU campuses. Through a multi-phase competitive approach, this Prize aims to build the capacity of TCU students to use clean energy and grow food self-sufficiently with sources on Tribal Lands. Finalists in Phase 3 of the prize will attend and speak at the 2025 Indian Energy Program Review. The Prize would be administered by the National Renewable Energy Lab (NREL) in partnership with the Office of Indian Energy.

This ND covers the development of teaming, planning, and permitting (Phases 1 and 2A). Phase 2B (construction) and Phase 3 (presentation and awards) would be submitted for NEPA review after Phase 2B is complete, and up to twenty winners of Phase 1 and 2A are selected.

## Phase 1: Teaming

Teams will recruit members and develop a plan for their energy and food sovereignty nexus demonstration projects.

## Phase 2A: Planning and Permitting

Winning teams from Phase 1 will complete all preparatory work required needed for project installation, including budget, timeline, and necessary permits and permissions. At the end of Phase 2A, up to 20 winning teams will receive a cash prize to purchase equipment and begin installation of their demonstration projects, as well as be eligible to compete in the Phase 2B.

The types of activities associated with Phases 1 and 2A of the prize would be limited exclusively to outreach, stakeholder engagement, information dissemination, project planning, modeling, desktop-based and/or non-invasive site evaluation and selection, preliminary engineering/design, and document preparation. Such work is expected to be conducted from existing offices and meeting space and not require any materials beyond basic office supplies and computers. DOE has considered the nature of the proposed activities to determine potential impacts on sensitive resources, including those of a biological, ecological, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.

Further NEPA review would be required prior to awarding cash prizes to teams who successfully complete Phases 1 and 2A. Each team is required to submit proposed project information to the cognizant Prize Administrator and must receive a NEPA determination prior to commencing work associated with subsequent phases.

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

#### FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
