

Proposed Action Title: Remove Out of Service Components at 780-2A

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Chemical addition components on the north wall of 780-2A are abandoned and no longer functional. Remove electrical feed to abandoned junction boxes and pump receptacles. Remove abandoned stainless steel piping, tubing, and support structure.
