

Proposed Action Title: Emergency Operations Replacement Project

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The Emergency Operations Center (EOC) has operated beyond its expected lifetime and has become inadequate to provide necessary response for possible emergency event scenarios. The functions performed in the Savannah River Site Operations Center (SRSOC) and the Emergency Operations Center (EOC) must be relocated to another area to meet the continuing mission requirements. There are two emergency management operations; the Savannah River Site Operations Center (SRSOC) and the Emergency Operations Center (EOC). The SRSOC and EOC are communications facilities where all site emergencies are managed, and the facilities are critical to support EM missions as well as enduring NNSA missions at SRS.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
