Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B3.6 Small-scale research and development, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) laboratory operations, frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Florida Solar Energy Center at the University of Central Florida (FSEC) to design, develop, fabricate, and test a small-capacity extreme weather resilient portable cooler (PC) for usage in sustained power outages.

The project would be completed over two Budget Periods (BPs) and ten Tasks. The project field testing site has not yet been determined. As such, this NEPA Determination only applies to BP1. Proposed activities BP1 would include project management, planning, drafting an interview plan, PC prototype development, PC laboratory-scale testing, simulations, parametric analyses, and modeling. At this time, there is insufficient information related to BP2 to perform a meaningful NEPA review as location information for activities in BP2 is currently undefined and is reliant on information gathered in BP1 Tasks 1-6, such as site and design specifications.

Award activities including design, development, and prototype fabrication would take place at Transaera Greentown Labs (Somerville, MA), and the prototype would be shipped to FSEC (Cocoa, FL) for laboratory testing. Minor laboratory modifications would be carried out at FSEC, including upgrades to accommodate updated equipment and airflow between chambers.

Individuals working on this project could be exposed to physical hazards, such as refrigerants and laboratory-scale equipment. Standard refrigerant safe-handling practices would be followed by licensed individuals in a laboratory setting. Refrigerants would be safely stored and transported in a designated storage container and extracted with appropriate recovery equipment.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.
