Description:

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to LUXTECH, LLC. for research and development related to the advancement of LED luminaries and related componentry.

Award activities would occur over two budget periods (BP). BP1 would include LED tube development and optimization, and luminaire design advancement. BP2 would include luminaire and system design advancement, project management, and reporting.

Award activities would occur at LUXTECH HQ in Boothwyn, PA.

Award activities would be intellectual, academic, or analytical in nature and would occur entirely within existing facilities that are purpose-built for the type and scale of activities being proposed. No change in the use, mission, or operation of existing facilities would arise out of this effort.

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on sensitive resources, including those of an ecological, historical, cultural, and socioeconomic nature, and found no effects that would be expected to result from the proposed project activities.
