Description:

A9 Information gathering, analysis, and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B3.6 Small-scale research and development, and pilot projects

Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) laboratory operations, frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Syracuse University for the design, development, and evaluation of a new deep energy retrofit system with integrated mechanical and panel system. These activities would include investigations on constructability, performance verification, pre- and post-installation monitoring, and evaluation and modeling of system performance. System development, modification, and modeling would occur at Syracuse College of Engineering's High Bay Laboratory, and pre- and post- monitoring would occur at a municipality-owned high-rise residential building, both located in Syracuse, New York.

There are no known hazards associated with project activities. Existing health and safety policies and procedures would be followed, including employee training, proper protective equipment, engineering controls, monitoring, and internal assessments. Additional policies and procedures would be implemented as necessary as new health and safety risks are identified.

All project work would be performed at existing laboratory and residential facilities. No modifications to existing facilities, ground disturbing activities, or changes to the use, mission, or operation of existing facilities would be required. DOE does not anticipate any impacts to resources of concern due to the proposed award activities.

DOE has considered the scale, duration, and nature of proposed activities to determine potential impacts on resources, including those of an ecological, historical, cultural, and socioeconomic nature. DOE does not anticipate impacts on these resources which would be considered significant or require DOE to consult with other agencies or stakeholders.
