Description:

A9 Information and dissemination

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and gathering, analysis, audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Biological Innovation and Optimization Systems, LLC (BIOS) for design and development of a high-efficacy luminaire platform, combining visual and wellness application efficiency.

Award activities would occur over two budget periods (BP). BP1 would include spectral and optical analysis and optimization, and LED development. BP2 would include luminaire design, prototyping, fabrication, application efficiency validation, project management, and reporting.

Award activities would occur at BIOS Lighting in Carlsbad, CA; Lumileds, LLC in San Jose, CA and Germany.

Award activities would be intellectual, academic, or analytical in nature and would occur entirely within existing facilities that are purpose-built for the type and scale of activities being proposed. No change in the use, mission, or operation of existing facilities would arise out of this effort.

Award activities would involve handling and use of various hazardous materials including organic solvents. Project activities involving hazardous materials would pose no risk to the public. Hazardous materials would be utilized, managed, stored, and disposed of in accordance with applicable federal, state, and local environmental regulations. Existing laboratory and governmental health and safety policies and procedures would be followed, including employee training, proper protective equipment, engineering controls, monitoring, and internal assessments.

DOE has considered the scale, duration, and nature of the proposed activities to determine potential impacts on sensitive resources, including those of an ecological, historical, cultural, and socioeconomic nature, and found no effects that would be expected to result from the proposed project activities.
