Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

B5.1 (a) Actions to conserve energy or water, demonstrate potential energy or water conservation, and promote energy Actions to efficiency that would not have the potential to cause significant changes in the indoor or outdoor concentrations of conserve potentially harmful substances. These actions may involve financial and technical assistance to individuals (such energy or as builders, owners, consultants, manufacturers, and designers), organizations (such as utilities), and water governments (such as state, local, and tribal). Covered actions include, but are not limited to weatherization (such as insulation and replacing windows and doors); programmed lowering of thermostat settings; placement of timers on hot water heaters; installation or replacement of energy efficient lighting, low-flow plumbing fixtures (such as faucets, toilets, and showerheads), heating, ventilation, and air conditioning systems, and appliances; installation of drip-irrigation systems; improvements in generator efficiency and appliance efficiency ratings; efficiency improvements for vehicles and transportation (such as fleet changeout); power storage (such as flywheels and batteries, generally less than 10 megawatt equivalent); transportation management systems (such as traffic signal control systems, car navigation, speed cameras, and automatic plate number recognition); development of energy-efficient manufacturing, industrial, or building practices; and small-scale energy efficiency and conservation research and development and small-scale pilot projects. Covered actions include building renovations or new structures, provided that they occur in a previously disturbed or developed area. Covered actions could involve commercial, residential, agricultural, academic, institutional, or industrial sectors. Covered actions do not include rulemakings, standard-settings, or proposed DOE legislation, except for those actions listed in B5.1(b) of this appendix. (b) Covered actions include rulemakings that establish energy conservation standards for consumer products and industrial equipment, provided that the actions would not: (1) have the potential to cause a significant change in manufacturing infrastructure (such as construction of new manufacturing plants with considerable associated ground disturbance); (2) involve significant unresolved conflicts concerning alternative uses of available resources (such as rare or limited raw materials); (3) have the potential to result in a significant increase in the disposal of materials posing significant risks to human health and the environment (such as RCRA hazardous wastes); or (4) have the potential to cause a significant increase in energy consumption in a state or region.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to administer Congressionally Directed Spending to the University of New Hampshire (UNH) to design, engineer, and construct a back pressure steam turbine (BPST), which would provide enhanced ability to reduce electrical grid demand through better utilization of steam generated from the campus cogeneration plant.

Proposed project activities would include the installation of a BPST at UNH's Combined Heat and Power Plant (plant) in Durham, NH. The BPST would be connected to the existing steam piping system. Additional project activities would include the installation of a new low-pressure steam condensing unit on the roof of the plant.

Project activities may involve the use of heavy equipment and working with electricity during the installation. Existing health, safety, and environmental policies and procedures would be followed, including personnel training, proper personal protective equipment, engineering controls, monitoring, and internal assessments. All required permits, licenses, and authorizations would be obtained prior to construction activities. There would be no ground disturbing activities as part of this project. No change in the use, mission, or operation of existing facilities would arise out of this effort. DOE does not anticipate any impacts to resources of concern due to the proposed activities of the project.

In conjunction with the recipient, a DOE consultation letter was sent to the New Hampshire State Historic Preservation Office (SHPO) per Section 106 of the National Historic Preservation Act of 1966, as amended, to determine potential impacts to historic properties. The UNH campus is a historic district. On November 5, 2024, the recipient and DOE received concurrence from the New Hampshire SHPO that this project would have no adverse effect to historic
