# Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to the Alaska Housing Finance Corporation in Anchorage, AK under the Energy Future Grants (EFG) Creating a Community-Led Energy Future, Funding Opportunity Announcement (FOA) Number: DE-FOA-0002870.

This NEPA determination is specific to activities under Task 1,2,4, and 5. Proposed activities would include hiring and coordinating meetings for a steering committee and design team, assessment of energy and housing needs, community engagement efforts, and preliminary schematic and design work for a culturally appropriate, multi-use housing design using a high level of energy efficiency measures in one of the most energy intensive regions of the country. No ground disturbing activities would occur in Tasks 1, 2, 4, and 5.

Further NEPA review would be required for Task 3 (site evaluations) once those activities have been defined and negotiated.
