Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination	Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. B3.6 Small-scale research and development, laboratory operations, and pilot projects	Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing provide federal funding to The University of Florida for the scale up and field testing of an efficient dehumidification system to reduce operational and capital expenses while improving indoor air quality in the built environment.

System design and fabrication would occur at The University of Florida in Gainesville, Florida; field testing would occur at The University of Florida's Shands Hospital in Gainesville, Florida; and laboratory testing would occur at GTI Energy in Des Plaines, Illinois.

Potential hazards include exposure to chemicals and fabrication equipment. Handling, storage, and disposal of hazardous materials and operation of equipment would occur within controlled settings and would follow existing laboratory policies and procedures. Existing health, safety, and environmental policies and procedures would be followed at all facilities, including personnel training, proper personal protective equipment, engineering controls, monitoring, and internal assessments.

All project activities would be completed in existing, purpose-built laboratory facilities. No facility modifications, new permits, or licenses would be required. DOE does not anticipate any impacts to resources of concern due to the proposed project activities.
