Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Rationale for determination:

In November 2022, the U.S. Department of Energy (DOE) issued a Broad Agency Announcement indicating an interest in entering into one or multiple agreements with Partnership Intermediaries (PI) to work with DOE's Office of Technology Transfer, other DOE programs, and DOE National Laboratories and Facilities. Through one or more Partnership Intermediary Agreement (PIA), DOE would expand its capabilities to connect and engage with the broader energy and national security ecosystem and address gaps facing companies, organizations and communities seeking to engage with DOE and/or develop, scale, commercialize, deploy, and adopt technologies relevant to DOE's mission.

DOE is currently proposing to execute a PIA with TechWERX (Houston, Texas) serve as the PI for the Connected Communities program. Through Connected Communities, the Office of Energy Efficiency and Renewable Energy aims to increase the acceptance of grid-edge technical measures and innovative planning strategies by utilities, communities, and public utility commissions as viable approaches toward efficient infrastructure investment for decarbonization. Specific measures would include enabling demonstration of smart charge management for electric vehicles that provides grid support, improves EV economics, and supports customer resilience. There is an increased emphasis on resilience for customers and the grid as both face growing loads, extreme weather events, and cyber threats.

The PI would focus on data collection and analysis. Federal funds would be spent primarily on readiness assessments for new loads and controls within buildings, leveraging of existing distribution facilities and evaluation of measures to reduce the level of necessary future investment, and analysis of increased customer and grid resilience. No laboratory or field work would be involved. The proposed work would not result in the modification of existing facilities or new construction projects.

Based on the types of activities proposed, DOE does not anticipate any adverse impacts to sensitive resources as a result of the execution of this PIA with TechWERX.

NEPA PROVISION

FOR CATEGORICAL EXCLUSION DETERMINATIONS

The proposed action (or the part of the proposal defined in the Rationale above) fits within a class of actions that is listed in Appendix A or B to 10 CFR Part 1021, Subpart D. To fit within the classes of actions listed in 10 CFR Part 1021, Subpart D, Appendix B, a proposal must be one that would not: (1) threaten a violation of applicable statutory, regulatory, or permit requirements for environment, safety, and health, or similar requirements of DOE or Executive Orders; (2) require siting and construction or major expansion of waste storage, disposal, recovery, or treatment facilities (including incinerators), but the proposal may include categorically excluded waste storage, disposal, recovery, or treatment actions or facilities; (3) disturb hazardous substances, pollutants, contaminants, or CERCLA-excluded petroleum and natural gas products that preexist in the environment such that there would be uncontrolled or unpermitted releases; (4) have the potential to cause significant impacts on environmentally sensitive resources, including, but not limited to, those listed in paragraph B(4) of 10 CFR Part 1021, Subpart D, Appendix B; (5) involve genetically engineered organisms, synthetic biology, governmentally designated noxious weeds, or invasive species, unless the proposed activity would be contained or confined in a manner designed and operated to prevent unauthorized release into the environment and conducted in accordance with applicable requirements, such as those listed in paragraph B(5) of 10 CFR Part 1021, Subpart D, Appendix B.

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
