FIRST AMENDED PROGRAMMATIC NEPA DETERMINATION (See attached original Programmatic Determination, dated July 7, 2020)
The PERFORM Program seeks to develop innovative management systems that represent the relative delivery risks of each asset, like wind farms or power plants, and balance the collective risk of all assets across the grid. If successful, the PERFORM teams will develop the tools to further optimize renewable resources into the grid, improve reliability, reduce energy imports, and further strengthen a pathway to sustainable energy independence.

The PERFORM Program is composed of 10 small-scale research and development projects that will be conducted by universities, non-profit entities, for-profit entities, and federal laboratories. This First Amended Determination adds 2 projects (Columbia University and Princeton University) to the Determination signed on July 7, 2020 (see Attachment for all 10 projects covered by this and the prior Determination). All 10 projects fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the projects. This assessment was based on a review of the proposed scope of work and the potential environmental impacts of each project. All project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and Local regulatory requirements.

Proposed Action Title: Performance-based Energy Resource Feedback, Optimization, and Risk Management (PERFORM) (FOA No. DE-FOA-0002171) Program

Proposed Action Description:

The PERFORM Program seeks to develop innovative management systems that represent the relative delivery risks of each asset, like wind farms or power plants, and balance the collective risk of all assets across the grid. PERFORM teams will (1) design risk scores that communicate the delivery risk of an asset's offer, such as the reliability of electricity from a solar plant due to the weather on a given day (2) develop grid management systems that internally capture uncertainty, and (3) evaluate the system risk to meet or exceed a set baseline. This risk-driven paradigm will enable grid operators to better maintain a supply-demand balance and system reliability, even with the intermittency of renewables. If successful, the PERFORM teams will develop the tools to further optimize renewable resources into the grid, improve reliability, reduce energy imports, and further strengthen a pathway to sustainable energy independence.

The PERFORM Program is composed of 10 small-scale research and development projects that will be conducted by universities, non-profit entities, for-profit entities, and federal laboratories. This Determination covers 8 of the 10 projects (listed in Attachment A). All 8 projects fit within the class of actions identified under the DOE Categorical Exclusion identified below and do not involve any extraordinary circumstances that may affect the significance of the environmental effects of the projects. This assessment was based on a review of the proposed scope of work and the potential environmental impacts of each project. All project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and Local regulatory requirements.
