Proposed Action Description:

Due to their age, the MAC solenoid valves for the Room Air Monitoring System located in solenoid valve rack SCLU-RK-44R3 require replacement.

Revision 0 of this EEC currently addresses the design and procurement portions of this modification. This EEC will be revised to include the facility modification portion of the work prior to construction and installation.
