Proposed Action Title: Replacement of Bldg. 784-7A Fire Detection and Alarm System

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Replace Fire Alarm Panel at 784-7A. The existing Simplex 4100 Fire Alarm Control Panel (FACP) installed in the 784-7A Steam Plant is obsolete with spare parts no longer available and needs to be replaced. The initiating devices and notification appliances in building 784-7A are not compatible with a new addressable panel and also need to be replaced.

The scope of this DCP is to replace the existing Simplex FACP with a new Notifier FACP, UDACT and supporting field components. Replace the initiating devices and notification appliances with addressable counterparts that are compatible with the new panel. Perform D&R of currently installed fire alarm system equipment.
