

Proposed Action Title: Remove Wooden Transformer Platform at 501-A

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Remove the wooden transformer platform at 501-A per E-FCR-A-00216 which will consist of performing electrical modifications such as removing existing power poles, overhead power lines, installing new power poles, overhead powerlines, disconnects, area street lighting.
