Proposed Action Title: Replace Fire Alarm Panel at 789-2B

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Existing 789-2B conventional Notifier SFP 10UD Fire Alarm Control Panel (FACP) is obsolete, spare parts are no longer available, and needs to be replaced. Existing initiating devices and notification appliances in building 789-2B are not compatible with a new addressable panel and also require replacement. Replace existing 789-2B Notifier SFP 10UD conventional FACP with new addressable Notifier NFS-320SYS FACP, along with all existing non-addressable initiating and notification devices.
