

Proposed Action Title: Ce Residue Flammability Evaluation

Proposed Action Description:

This work is to inform design of larger scale experiments and provide a better understanding of the interactions between pyrophoric residue and flammable materials. The EEC will cover the small scale t;50 gm generation of Cerium Oxide and ash by combustion involving paper waste and Cerium dust/filings.
