

Proposed Action Title: Pyrochemical Operations in a Glove Box

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

This EEC covers the use of the non-rad pyroprocessing system. The pyroprocessing operations to be tested on this system are molten salt extraction (MSE), electrorefining (ER), direct oxide reduction (DOR), anode casting (ACast), salt oxidation (SOx), salt scrub (SS), and chlorinated metal production.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
