Proposed Action Title: General Electric Global Research -- Advanced Medium Voltage SiC-SJ FETs with Ultra-Low On-resistance

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project team's small-scale research and development activities to fabricate and demonstrate the world's first high voltage silicon carbide (SiC) super junction (SJ) Field Effect Transistors (FETs) that will surpass conventional devices for medium voltage applications. Specifically, the project team will (1) design test structures and complete 2D and 3D numerical simulations to optimize new structures; (2) demonstrate low leakage diodes; and (3) fabricate and test 4.5kV and 6.5kV SiC-SJ FETs. If successful, the project team will demonstrate the world's first 6.5kV SiC SJ-MOSFETs with ultra-low on-resistance, 50% below the conventional unipolar physical limit. The technology may enable new devices capable of scaling to high voltage while offering up to 10x lower losses compared to commercially available technologies and up to 2x lower losses compared to emerging SiC options.

Project activities will be conducted at existing facilities at GE Global Research (Niskayuna, NY) and Rensselaer Polytechnic Institute (Troy, NY) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.


