

Proposed Action Title: Relocation of Segregated Solvent Filters in F-Area

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

## Proposed Action Description:

The proposed activity is to assist Non-destructive Assay (NDA) group with radiological assays and to relocate the segregated solvent filters from the 80-4F pad to the 221-F Canyon.
