Proposed Action Title: Pitot Tube Location Modification to Support Canyon Exhaust (CAEX) Tunnel Inspections

Proposed Action Description:

M-DCF-H-13130, Revision 1 will replace two (2) existing flanged connections that currently have instrument tubing with solid blind flanges. The instrument tubing to the flanges has already been disconnected. This change will ensure a robust closure of the two (2) penetrations into the CAEX Air Tunnel and remove reliance on tubing valves. The design will remove the disconnected tubing and a local magnehelic gage cabinet, any tubing from 292-H will be plugged. Shorten the two(2) horizontal sections of tubing back to within 2-3 inches of the vertical tubing support structure and cap tubing off.
