## Proposed Action Description:

Revision 2: There are 12 total transformers, three on each of the 4 Precipitators. Through drone flights, we were able to verify the 12 transformers were marked with the Non-PCB sticker, also confirmed by historical data and WO01232700 (Drain oil from Precipitator transformers). Emptied, the transformers can be released to the CRO. The drained oil, which is >2ppm but t;50 ppm, will be managed as off-spec used oil through Solid Waste Management.

Revision 3: D-Area demolition and removal of following domestic water facilities/equipment: building 483-7D, 905-5D water tower, ancillary structures 452-7D, 452-10D & 452-11D, 905-3D & 905-136D. The work also includes the removal of all asbestos insulation, piping and pipe supports from a portion of the primary pipe bridge of steam lines.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

In the proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
