Proposed Action Description:

GTSTG uses the Environmental chamber (EC) in 723-A for Function testing as requested by the DA's and for unloading as requested by SRTE. The unique characteristics afforded by the environmental chamber allows for proper and safe removal of gas from highly pressurized bottles to position them in a safer state and to measure desired values as gas transfer occurs.
