This EEC only involves the transfer of sieve material between glass bottles and sample modules. It is being conducted in a glovebox to protect it from moisture. The sieve material will collect noble gases where collection efficiencies of the gases can be determined under a different EEC. The work is performed in building 735-A labs D-007 and A-132.
